

TERMS & CONDITIONS

Confirmation & Payment

November - December

Full payment for the cost of Barefoot Bowls must be made within 72 hours upon invoice being issued to secure any booking. Unless made at the time of booking, Catering requirements must be booked no later than two weeks prior to a function and payment must be made within 72 hours upon invoice being issued.

For Drink Packages (unless made at the time of booking), numbers must be confirmed and payment made prior to event.

Any outstanding beverage tabs are to be settled on the conclusion of function. Under no circumstance will extension of payment be permitted.

January - October

A 50% deposit of the total number of Barefoot Bowlers is required for groups of over 20 or more within 72 hours of invoice being issued to secure any booking. The balance is payable on the day of the function.

Unless made at the time of booking, Catering requirements must be booked no later than one week prior to a function and payment must be made within 72 hours upon invoice being issued.

For Drink Packages (unless made at the time of booking), numbers must be confirmed and payment made prior to event.

Any outstanding beverage tabs are to be settled on the conclusion of function. Under no circumstance will extension of payment be permitted.

Please Note: Upon receipt of your booking enquiry The Marrickville Bowling & Recreation Club will issue an invoice for the cost of Barefoot Bowls booking along with Catering Requirements and Drink Packages if requested at the time of booking. Any booking is deemed as tentative until payment is made within 72 hours of invoice being issued and may be cancelled by the venue.

CATERING

If your function requires catering to be ordered subsequent to this booking please contact the Fitzroy's Kitchen directly at fitzroyskitchen@gmail.com. You can enquire and order directly from them. You will be issued an invoice directly from Fitzroy's Kitchen unless catering is booked along with this form.

TABLES

As we get very busy at some stages of the year, outdoor tables are prioritised for Barefoot Bowling groups. Generally, one table is booked per rink for the duration of your Barefoot Bowling booking. We do endeavour to accommodate all groups wishes.

CANCELLATION

Any cancellation made within two weeks of the function date, will forfeit payment or deposit for Barefoot Bowls and/or catering.

If any Drink Packages have been purchased prior to function, a full refund will be made in the event of cancellation.

WET WEATHER

In the event of wet weather and the Greens being closed, a full refund of payment/deposit of Barefoot Bowls will be applicable.

As there is plenty of space and fun to be had at The Club, if Barefoot Bowls is cancelled due to wet weather, no refund is applicable for Catering payments unless cancelled 1 week prior to function date.

BAREFOOT BOWLS

As we get very busy at times we encourage guests to arrive early allowing plenty of time to get out bowling at their allocated time. Any group that starts after their scheduled time may not be able to enjoy a full two hours on the green. No refund will be given if a group is not ready to bowl at their scheduled time

We encourage all Bowlers to be Sun Smart and wear hats and sunscreen. The Club supplies Sunscreen for guests.

While we encourage people to come down and enjoy Barefoot Bowls, our Greens are also used for competition Lawn Bowls and thank guests for adhering to the following rules on the green.

- Each 'Rink' is for up to ten bowlers
- Unless bowling, no one is permitted on the green/s.
- Unless barefoot, only flat rubber soled shoes (sneakers, thongs etc.) are to be worn on the green.
- Only ten bowlers are permitted to play per rink.
- No throwing or driving bowls (throwing them like ten pin bowls)
- People (feet) must remain out of the ditches while bowling.

Due to safety concerns, no children under 8 are permitted to bowl or be on the green/s and any bookings for children under 12 must be discussed with Functions Co-Ordinator at the time of booking.

SIGNING IN

As per the Registered Clubs Act, anybody entering the venue who is not a member of The Marrickville Bowling & Recreation Club must fill in the temporary member register.

Any person/s who lives outside a 5km radius of Marrickville or is a member of another Bowling Club may sign in as a temporary member.

Any person/s who live within a 5km radius of Marrickville must be signed in by an accompanying member or, themselves become a member of The Marrickville Bowling & Recreation Club. Individuals are permitted to join as provisional members on the day at a cost of \$10.

Valid photo identification with current address is required for entry into The Marrickville bowling & Recreation Club. If any person/s doesn't have valid identification, they will not be permitted to enter the venue.

RESPONSIBLE SERVICE OF ALCOHOL

Drink packages booked are for middies or schooners of draught beer and glasses of wine – Jugs of Draught Beer and bottles of wine will not be served with Drink Packages.

In accordance with NSW State Governments RSA laws, The Marrickville Bowling & Recreation Club reserves the right to remove any person/s deemed to be intoxicated or in breach of state laws at our discretion and without liability. No refund of Drink Packages will be applicable if any person/s are removed due to breach of RSA laws.

OTHER

Entrance to The Marrickville Bowling & Recreation Club assumes responsibility to adhere to behaviour that is becoming of The Club, any persons showing behaviour that is deemed anti-social or contrary to our Code of Conduct (available on our website) will be asked to leave and referred to the relevant authorities if required.
