# BAREFOOT BOWLING

*Yes, it's real grass.*

## Booking Category & Security

- A 50% deposit of the total number of barefoot bowlers (\$15 per bowler for two hours) is required for groups of 20 or more within 72 hours of invoice being issued to secure any booking.
- **A security deposit is required for all off-peak barefoot bowls bookings.** This is returned once all bowls are returned in good condition. The deposit can be either:
  - a **\$200 credit card pre-authorization, or**
  - a **physical credit card and photo ID held by the venue.**
- The deposit is released at the end of the booking once equipment has been checked.

## Green Rules & Conditions of Play

Our greens are used for both social and competitive bowls and are costly to maintain. All guests must adhere to the following:

- Maximum 10 bowlers per rink.
- **Children under 16** are not permitted on the greens or in sand traps.
- Barefoot on the greens at all times. Shoes must be worn inside the clubhouse.
  - No throwing, bouncing or driving bowls.
  - Only active bowlers are permitted on the greens.
  - People and feet must remain out of ditches (sand traps).

Failure to comply may result in removal from the greens or venue at the discretion of management.

## Capacity

To ensure the comfort and safety of all guests, each rink booking is designed to accommodate up to 10 bowlers. This allocation also forms part of our overall venue capacity around the greens. Once all rinks are booked, the surrounding outdoor space is considered at full capacity. As a result, we are **unable to accommodate additional spectators or significantly larger groups than the number of bowlers booked.**

## Wet Weather

If the greens are closed due to inclement weather, bowling payments or deposits will be refunded in accordance with the Terms & Conditions on Page 5.

The decision to close the greens rests solely with the Greenkeeper on the day.

*Please note that our drinks packages are **only applicable to whole groups**. We recommend setting up a bar tab on the day if not all attendees are interested in a package.*

# TERMS AND CONDITIONS

**CONFIRMATION AND PAYMENT:** A 50% deposit of the total number of barefoot bowlers (\$15 per bowler for two hours) is required for groups of 20 or more within 72 hours of invoice being issued to secure any booking. The remaining balance is payable on the day of your function reflective of the total number of attendees. Any invoices unpaid after 72 hours will be voided and result in the forfeiture of any tentative booking.

**SECURITY DEPOSIT:** A \$200 security deposit is required for all **off peak** barefoot bowls bookings. The deposit may be processed as a \$200 credit card pre-authorization or by holding a physical credit card and photo ID with the venue for the duration of the booking. The deposit will be released at the conclusion of the booking once all bowls have been returned in good condition and checked by staff. The venue reserves the right to retain the deposit in part or full in the event of missing or damaged equipment.

**DRINKS PACKAGES:** Drinks packages (unless made at time of booking) must be confirmed and payment made at least two weeks prior to your function. Any outstanding beverage tabs to be settled at the conclusion of function. *Under no circumstances will extension of payment be permitted.*

**TABLES:** Outdoor reservations are prioritized for our barefoot bowling groups. Every 'rink' will receive an allocated area beside the green for the duration of its bowling reservation. While decorations are welcome, all decorations must be removed prior to departure. Permanent fixtures are prohibited and the event organizer is liable for any damage caused to club property. The venue does not reserve tables for non-bowling groups or non-participants.

**CANCELLATION POLICY:** Any barefoot bowling cancellation made within two weeks of the function date will forfeit payment or deposit to the venue.

**EXTREME/INCLEMENT WEATHER POLICY:** In the event the greens are closed, a full refund of bowling payment/deposit will be applicable. The decision is made at the discretion of our greenkeeper on the day.

**BAREFOOT BOWLS:** Due to high turnover rates on the green, we encourage guests to arrive early allowing plenty of time for coaching, signing in and other logistics. Any group commencing bowling after their scheduled time may not be entitled to their full 2 hours on the green. A refund will not be applicable in the event a group is not ready to bowl at their scheduled time.

Our greens are also used for competitive bowls and are expensive to maintain. ***Guests are expected to adhere to the following rules of play on the green*** – failure to comply may result in removal from the greens and/or venue at the discretion of the manager on duty. Rules of play include:

- Each 'rink' is for up to 10 bowlers only, with up to 7 rinks applicable at any time pending other bookings.
- Kids under the age of 16 are not permitted on the green/s or in the sand at any time for safety reasons.
- Unless bowling, no persons are permitted on the green/s.
- Barefoot only. Shoes are required inside the clubhouse at all times.
- No throwing, bouncing or driving (like ten pin) bowls.
- People and feet must remain out of ditches (sand traps) while bowling.

**RESPONSIBLE SERVICE OF ALCOHOL:** Drinks packages booked are for middies and schooners of draught beer/cider and glasses of wine. Jugs of beer and bottles of wine will not be served in accordance with drinks packages. Drink packages must be booked for all attendees and cannot be applied to select persons in a group. In accordance with NSW State Government RSA laws, the venue reserves the right to remove any person/s deemed to be intoxicated or in breach of state laws at our discretion and without liability. No refund of drinks packages will be applicable if any person/s are removed due to breach of RSA laws.

**BUCKS AND HENS PARTIES:** The designated booking times for bucks' parties is 11am-2pm. Such events must vacate the premises by 2pm at the latest. Bucks' parties that are not specified at the time of booking may be subject to removal from the greens/venue and a forfeiture of any deposit paid.

**18<sup>th</sup> & 21<sup>st</sup> BIRTHDAY PARTIES:** The venue does not host 18<sup>th</sup> or 21<sup>st</sup> birthday parties. Such events that are not specified at the time of booking may be subject to removal from the greens/venue and a forfeiture of any deposit paid.

**OTHER:** Entrance to the MBRC assumes responsibility to adhere to behavior that is becoming of the venue. Any person/s showing behavior that is deemed anti-social or contrary to our code of conduct (available on our website) will be asked to leave and referred to the relevant authorities if required.
